

## Common Measures: Descriptions, Training, Materials, & Cost

The following Technical Assistance Brief provides a description of each of the common measures used in the Common Measures Initiative (CMI). The brief discusses the materials and training required for administration of the common measures. It also presents the related costs of the required materials and training by each of the measures. Information regarding additional, optional materials and purchasing information is included in this brief.

### ASQ-3

The Ages and Stages Questionnaire, 3<sup>rd</sup> Edition (ASQ-3) is a developmental screener, which focuses on five key areas: Communication, Gross Motor, Fine Motor, Problem Solving, and Personal-Social. There are twenty-one age specific questionnaires for children ages 2-60 months old. A parent or guardian typically completes the ASQ-3; however, a teacher or childcare provider may also complete the screener. The ASQ-3 takes 10-15 minutes to complete and must be administered on *ALL* children receiving direct services.

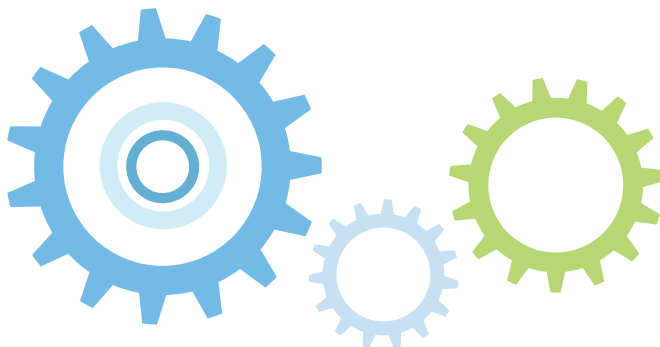

## ASQ:SE

The Ages and Stages Questionnaire: Social-Emotional (ASQ: SE) is a social-emotional screener, which focuses on the areas of Self-Regulation, Compliance, Communication, Adaptive Behaviors, Autonomy, Affect, and Interactions with People. There are eight age-specific questionnaires for children ages 3-66 months old. A parent or guardian typically completes the ASQ: SE; however, a teacher or childcare provider may also complete the screener. The ASQ: SE takes 10-15 minutes to complete and must be administered on *ALL* children receiving direct services.

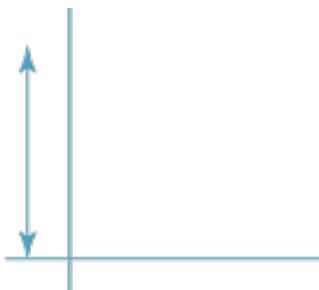
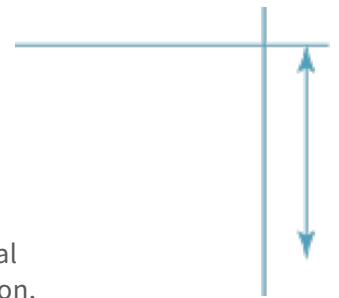

## DECA

The Devereux Early Childhood Assessment for Infants/Toddlers/Preschoolers (DECA I/T/P2) are observational assessments used to evaluate young children's social-emotional strengths found to be associated with resiliency or protective factors. The DECA-I is used to assess children between the ages of 1-18 months old, the DECA-T is used for children ages 18-36 months old, and DECA-P2 is used with children 3-5 years old. The assessment will be utilized with children receiving Classroom Consultation, including Positive Behavioral Supports, the Pyramid Model, Mental Health Consultation, and Behavioral Health. The DECA's take 10-20 minutes to complete and should be administered twice: once at the beginning of services and once following the completion of services or twice during a program year (fall and spring). The assessment should be conducted by a teacher or classroom consultant who has known the child for at least 30 days prior to the beginning of consultation services.

## IGDIs

The Individual Growth and Development Indicators (IGDIs) is an observational assessment consisting of a set of measures to monitor infant and toddler growth and progress overtime. The IGDIs are used to assess children between the ages of 6-42 months old receiving higher levels of early childhood education and care services. Children will be assessed with the Communication and Problem Solving indicators of the IGDIs. The assessment takes 6 minutes per indicator to complete and must be conducted twice per academic year (once in the fall and once in the spring).

### Required Training

- One day, observational training and reliability testing required
- Required materials will be provided on the day of training



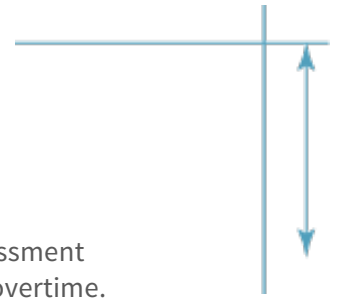
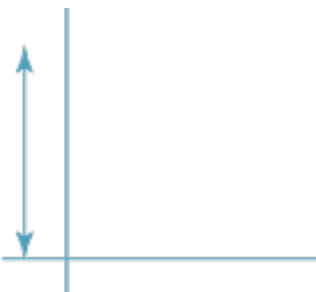
### Required Toys for IGDIs Administration

- Toys for Communication (ECI)

## myIGDIs

The myIGDIs are a set of assessments for monitoring the growth and development of preschool children. The myIGDIs narrow the focus to literacy and numeracy for preschool, consistent with the goals of the Children's Cabinet and school readiness. The myIGDIs are used to assess children receiving PreK. The assessment has two main areas of focus: Numeracy and Literacy+. The Numeracy component is for children between the ages of 3.5-5 years old, while the Literacy+ component is for children 4-5 years old. The myIGDIs takes 5-10 minutes per area (10-20 minutes total) and must be conducted three times within the myIGDIs administration test windows.

### Required Training

- One full day and one half day of training required

## HOME

The Home Observation for the Measurement of the Environment Inventory (HOME) is an observational and interview assessment designed to measure the quality and extent of stimulation and parental interaction available to a child in the home environment. The HOME I/T (Infant & Toddler) is used to assess children between the ages of 0-3 years old, while the HOME EC (Early Childhood) is used for children ages 3-6 years old. The HOME will be utilized in home visiting programs conducting one or more home visits per month and should be completed by a home visitor. The administration of the assessment requires a home visit of one hour duration to complete and must be done twice a year.

### Required Training

- No formal training required

## KIPS

The Keys to Interactive Parenting Scale (KIPS) is an observational assessment of parenting behavior and parent-child interaction for families with children between the ages of 2 months- 6 years old. The KIPS will be utilized with any program providing parent education, and it will also be required in home visiting programs conducting more than three home visits per month. The administration of the assessment takes 20 minutes to complete and must be conducted twice: once at the beginning of services and once following the completion of services or twice during a program year.

### Required Training

- Observational training and reliability testing is required
- Online training and certification is available through the official KIPS website
  - Introductory KIPS eLearning© = \$155.00 per learner

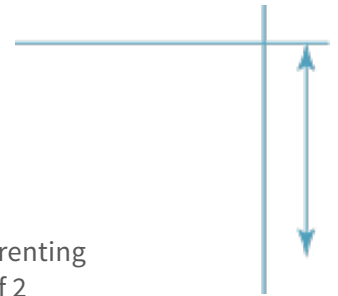
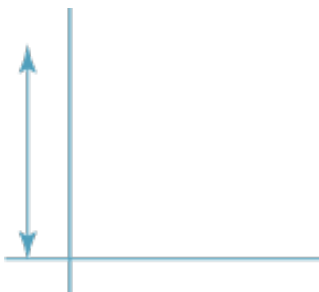

## CLASS

The Classroom Assessment Scoring System (CLASS) is an observational tool for assessing relational and environmental quality among classrooms with young children. The CLASS-Toddler is used to assess quality in classrooms or childcare settings with children between the ages of 15 months – 36 months old, while the CLASS-PreK is used in classrooms with children 3 years old and up. The CLASS takes 2 hours total to complete and is broken down into 4 30-minute cycles. Each 30-minute cycle consists of 20 minutes of observation and then 10 minutes of recording information. *Every* classroom must have a complete assessment (minimum of 4 20-minute cycles) once in the fall of the academic school year. For a classroom that does not meet the quality standards during the fall assessment, the classroom must then complete a second observational assessment in the spring of the academic school year.

- Separate trainings are required for the CLASS-T and the CLASS-Pre-K
- Both trainings involve a two-day training session where you will be instructed in observation and coding skills by a certified CLASS trainer



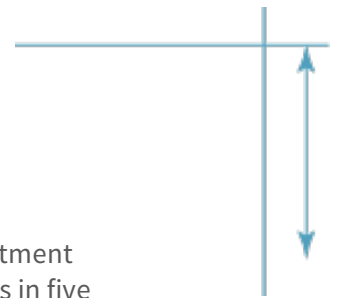

## Protective Factors Survey (PFS)

The PFS is a pre-post evaluation tool for use with caregivers receiving child maltreatment prevention services. It is a self-administered survey that measures protective factors in five areas: family functioning/resiliency, social support, concrete support, nurturing and attachment, and knowledge of parenting/child development. It is designed for use with caregivers receiving child maltreatment prevention services (program participants) such as home visiting, parent education, and family support. There are components of the survey that can be completed by service providers/programs, but they are optional.
