KANSAS CHILD CARE TAX CREDIT POLICY

MITCH RUCKER, KANSAS ACTION FOR CHILDREN



Employer Child Care Tax Credit

- Current makeup
 - Only available to C-Corporations and Privilege Tax payers (banks)
 - Capped at \$3 million in total credits
 - Covers 50% of net expenses in the first year, up to \$45,000 for employers that provide on-site care, drops to 30% up to \$30,000 in subsequent years
 - Covers 30% of net expenses up to \$30,000 for employers who pay for child care services in all years
 - Fully refundable

Employer Child Care Tax Credit

- Proposed changes
 - Expand eligibility to all types of businesses
 - Eliminate reduction in eligible expenses for on-site care
- Rationale for change
 - The credit is currently under-utilized, expanding eligibility should increase use, and help more Kansas families afford child care.
 - A bill provides a concrete issue to get lawmakers on board with investing funds in child care.
 - These changes will have no net impact on the state budget.

PROPOSED PLAIN LANGUAGE CHANGES



BACKGROUND

One of the norms listed in the "Role, Norms, and Procedures of the Panel" is **clarity:** the Panel will use clear language to make it easier for all Kansans to understand and engage with its work.

- Replace "shall" with "must", "should", or "will"
- Simplify language and change passive voice to active voice
- Refer consistently to the "Children's Cabinet"

REFLECTIONS ON PANEL WORK



TIMELINE

- February 2020: Governor Kelly signs <u>Executive Order 20-02</u>, designating the Children's Cabinet as the state Early Childhood Advisory Council.
- April 2020: The Children's Cabinet appoints Kansas Early Childhood Recommendations Panel members.
- July 2020: First Early Childhood Recommendations Panel meeting.
- October 2020: The Panel makes its first recommendation to the Children's Cabinet.
- December 2020: The Children's Cabinet accepts the Kindergarten Transitions Recommendation and the accompanying toolkit.

- Better understanding of the various organization and developing a shared understanding of how to promote equitable access to high quality early childhood learning opportunities for each and every child and their family.
- Connecting the early learning community in a way that creates a strong altruistic community ready to activate opportunities and find unusual, positive solutions that lead to good public policy.



JULY RESPONSES - WHAT ONE ISSUE DO YOU WANT TO MAKE PROGRESS ON?

- Community empowerment for improved quality, easily accessible early childhood experiences for families and children.
- Collaborating to fill the gap between the services that are available to families and their actual needs
- Improved access to affordable early childhood educational programs.
