7. Kansas COVID-19 Reflections:

KDHE Child Care Licensing Temporary Closures: During the COVID-19 Pandemic KDHE Child Care Licensing has collected and continues to collect provider reported temporary closure and reopen data. Many providers reported

reopening after a short closure period that may have not been due to a specific exposure or positive test results, but rather an overall concern for the health of self, family or staff. KDHE Child Care Licensing Director Lorrena Kravitz will share a summary of point in time data over the past year.

Vaccine Update: Kansas is still focused on completing phase 2 in many counties. Child care workers (all individuals affiliated with facilities licensed by KDHE) are included in phase 2 and vaccination is underway in all counties. Click here to view the Kansas weekly vaccine updates.

Vaccine status and hesitancy from the Our Tomorrows Story Bank: The Our Tomorrows team recently added a question to the story collection tool to learn more about vaccination access, status, and messaging across the state.
