





## STATUTORY DUTIES

The Kansas children's cabinet shall review, assess and evaluate all uses of the moneys in the children's initiatives fund.

The Kansas children's cabinet shall have and perform the following functions:

- investigate and identify methodologies for the combining of funds across departmental boundaries to better serve children and families;
- propose actions needed to achieve coordination of funding and services across departmental lines.

- Early Childhood Infrastructure NEW \$1.4M
  - 1-800-CHILDREN
