EARLY CHILDHOOD TRANSITION TASKFORCE

E.O. No. 23-01 establishes the Early Childhood Transition Task Force. The Task Force is charged with reviewing Kansas' early childhood programs and developing a roadmap for the creation of a new state, cabinet-level agency focused solely on supporting the success of our youngest Kansans.

Vision: All Kansas children – especially those between zero and five years of age – deserve healthy childhoods that are supported by a robust early childhood system which improves outcomes and effectively provides high-quality early care and education, adapts to the needs of families and communities, and is equitably accessible to all communities across the state.







Child and Family Well-Being Dashboard

EARLY CHILDHOOD RECOMMENDATIONS PANEL DISCOVERY SESSION

OVERVIEW

- The University of Kansas Center for Public Partnerships and Research will develop an interactive dashboard of child and family well-being in Kansas.
- The interactive dashboard will allow for exploration of data related to Kansans' access to basic needs, community-level strengths and resource gaps, community-based family resources, and social determinants of health.
- The dashboard will use a strengths-based approach and serve as a visual tool for translating data to policy makers, private sector partners, and partners in the child and family well-being system.
- Dashboard development will be informed by child and family well-being stakeholders and individuals with lived experience, in addition to systematic meta-synthesis and methodological rigor.

All in for Kansas Kids Website – Communities Page

- Child Care Aware of Kansas' **Child Care Data By County** provides point-in-time information about the type, cost, and availability of child care in your county.
- Kansas Health Matters provides community health-related statistical data, local resources and gives communities the tools they need to read and understand the public health indicators that affect the quality of lives.
- The KSDE Data Center provides Kansas Education Reports including information on buildings, personnel, geographic boundaries, children's nutrition and wellness, and finance.

Kansas Community Data



What?

- Provides ready-to-share, community-specific data on topics ranging from poverty and employment rates to birth rate trends for every community across Kansas.
- Partnership with mySidewalk (KC-area) www.mysidewalk.com
- o 20 different indicators drawing from publicly-available data
- You select the geographic boundary you want to see
- o Dynamic data points, charts, and graphs all exportable
- The narrative to help **you** convey the importance of the data

Key Understandings

o Data is as updated as the source itself

• Select Place, County, or Census Tract for your data story


- Select up to 2 additional comparison geographies (place, county, census tract)
- Use overlays to help you make decisions on the geographies you want
- You will get the URL link to your data dashboard in your email inbox this will always contain the latest data (bookmark it!)
- Dashboard will also have county and statewide comparisons
- o 20 indicators divided into 4 categories

How it works

Select one or multiple counties, cities, or census tracts below, use the overlay list to gain community context, then <u>click the</u> **Request Dashboard button** to generate a custom Kansas Community Data Dashboard from mySidewalk. We also encourage you to review this <u>User Guide</u>, which walks you through how to interact specifically with the data and provides important details about data limitations. These limitations may influence how you determine to use or share the data.
