The **June 23**, **2023**, special session of the Kansas Children's Cabinet and Trust Fund Board virtual meeting commenced at 9:00 a.m. Chairman Kim Moore presiding. There was a quorum. Proper notice was published in the Kansas Register.

CHILD CARE CAPACITY ACCELERATOR GRANT PROPOSAL

Melissa Rooker, Executive Director, discussed the Child Care Capacity Accelerator Grant and introduced Lucas Neece, Federal Grant Manager on staff, who gave an overview of the RFP process, timelines, and review process.

Lucas reported that 105 Full Accelerator applications and 40 innovation Community Innovation Addon applications were received totaling \$124 million dollars requested. The funding available is \$43.5 million dollars. The breakdown on funding includes \$20 million dollars of SPARK funds, \$20 million CCDF-ARPA, \$1 million of PDG Planning funds, and \$2.5 million dollars in collaboration support from the Patterson Family Foundation. Lucas gave a breakdown of the recommended applicants by region. (see attached summary)

After considerable discussion, Chairman Moore asked for a motion.
