• Formed in October of 2022.



- Meet monthly with state and community leaders to discuss:
 - Emerging community child care capacity building challenges/barriers.
 Progress on community child care capacity building challenges/barriers.
 Systematic challenges impacting child care capacity-building efforts (such as local zoning issues, changes to licensing/regulations, funding needs, or other large-scale issues)
- **Purpose:** To quickly and efficiently mobilize local, regional, and state resources to address community-specific needs/barriers to building child care capacity.





Go Team Successes

- Worked with several state partners to help communities address capacity-building barriers.
- Collaborations with multiple communities to assist with child care facility building plans, supporting when closures happen, and when communities need to switch gears to meet requirements.
- Community reached out to about necessary building sketch requirements for fire marshal.
 - Go Team was tagged in, and the KSFM representative connected a fire chief to the individual within 24 hours and helped solve the issue.






Baby Steps -Increasing Access to Infant Care



Access to Child Care

Solutions often approach <u>child care</u> from one or more starting place(s):



Access to child care for infants is often overshadowed by the larger issue of access to child care for all children. Family child care programs cannot afford to provide care to infants, and families cannot afford to pay more.

Child Care Provider Survey Three Key Findings

- Sent to 167 programs 73% open rate 16% response rate (27 total) Response from programs that dor
- Response from programs that don't accept infants less than half that from those that do

For **all** providers (those that currently accept infants and those that do not), the majority indicate that they would accept two or three infants if loss of income were not a factor.

2

Providers that accept infants were **evenly split** when asked whether they would be willing to accept additional infants if loss of income were not a factor.

3

Providers that do not currently accept infants were **less likely** to indicate that loss of income is a factor (other factors at play, such as personal preference.)


Where to start

- ✓ High Social Vulnerability Index
- ✓ High birth rate
- Low desired capacity meets
 potential demand
- ✓ High children <3 per slot</p>

Additional levers

- For the year in which the incentive is received:
- Pass pre-screening intake to confirm the provider is a good fit for the most vulnerable population
- ✓ Clear licensing record with KDHE
- ✓ Agree to accept infants
- Agree to engage with Infant Toddler
 Specialist Network
- ✓ Agree complete quarterly touch base with Baby Steps coach

Program Highlights -

TOTAL IMPACT:

- ✓ Increased 94 infant slots
- ✓ Now available in 18 counties
- \checkmark 66% of the counties that participated saw an increase in access to infant care
- ✓ 7% more infant slots are being filled
- ✓ Providers have access to additional resources throughout the state
- ✓ Providers have increase income

Lessons learned:

- ✓ Providers do not have space
 - ✓ Originally started with 10 Kansas counties
 - \checkmark Expanded due to lack of infant spaces in the original 10 counties
- ✓ School year schedule
 - \checkmark More providers enrolled when spaces freed up with the school year
- ✓ License type
 - ✓ Group providers (2 adults in the home) were more likely to participate
 - ✓ Figuring cost for additional provider

 "Baby steps has made a big impact on me. Since starting the program, I have made the decision to transition to just doing infant care. It is important to me to be able to give as much one-on-one care and being enrolled in this program helped me to realize infant is where I want to be in my last years of childcare.

Having the Infant Toddler specialist has helped tremendously as well, and she helped me make more room for infants in the playroom and helped purchase age-appropriate toys and equipment geared more towards development and such. This program has mostly helped with subsidizing my income loss due to just having 3 infants. Even though it's a loss to me it's worth it being able to care for these infants in such a way as I can spend more time with them and help them grow and develop and make sure they are meeting the milestones. In the Baby steps program has allowed me to help 3 parents looking for infant childcare . One of the parents has been looking for 10 months and had to settle for a daycare center which is understaffed and she felt as though her child was not getting the attention she deserved. It just so happened that I had an opening and she was so happy to hear this. I have known the fathers family for years. As you know that having 3 infants in care cuts down on how many children you can have in care so the baby steps program has been a life saver for me monetary wise. It fills in the gap of not being able to have more kids. Thank you for offering me this pilot program. Not all daycare providers in Kansas were given this opportunity! I sincerely hope this program will continue to receive the funds so that the Baby Steps Pilot Program can continue to help providers so that the providers can help parents in need of infant care!! ✓ "The baby steps grant has really helped me with updating my baby pack and plays to take on another infant, and helping with my salary, as keeping a baby counts as two children. It really helped out the momma of the new baby I'm keeping as it is very difficult to find care for infants (there are a lot of daycares that do not take kids under 18 months) as this is understandable because the first infant counts at two children and that means you can only have 6 where if you don't have an infant (18 months and older) you can have seven so this grant is wonderful for making up some of the difference in pay!"

- Providers have reported they are more willing to enroll additional infants with the financial support and the coaching support that is provided through this program.
- Providers have enjoyed working with the ITSN program to further their knowledge and develop their skills in the early childhood field.


