# Maternal and Child Health (Title V) Statewide Needs Assessment

A mixed-methods assessment of MCH in Kansas

### What is the MCH Block Grant?

- ✓ Federal block grant program allocating money to states to promote health of women and children
- ✓ Funded since 1935 under Title V of the Social Security Act (oldest and largest state public health block grant program)
- ✓ Funding to states based on a formula based on state's population size and need

Estimated to serve over 60 million people annually (93% of all pregnant women, 99% of infants, and 61% of children nationwide)

# MCH (Title V) Program in Kansas

- ✓ Housed in the Bureau of Family Health at KDHE
- ✓ In SFY 2025 funding 55 local programs
- ✓ Goals:
  - ✓ Reduce infant deaths
  - ✓ Promote access to care for women, infants, children, and adolescents
  - ✓ Promote coordination of care for children with special health care needs

Federal requirement that states spend 30% or more of block grant dollars on services to children with special health care needs

## What is the statewide Needs Assessment?

- ✓ Required component of MCHBG application on a five-year cycle
- ✓ Includes information on:
  - ✓ Population health status of MCH populations
  - ✓ Program capacity and structure
  - ✓ Workforce capacity and workforce development
  - ✓ Partnerships and Collaboration
  - ✓ Identified priority needs (and linkage to performance measures)

A "comprehensive" needs assessment involves a clear structure for assembling data, engagement of stakeholders representing diverse communities, a structured priority-setting process involving families and diverse communities, and collaborative planning, evaluation, and continuous quality improvement.



# Many children/families struggle with basic needs



15.1% of Kansas children are living below the poverty line



White children 10.6%



Latino/Hispanic children 21.4%



Black/African American children 32.2%



12% below the national average



Only 9% of eligible Kansas families participate in TANF

Medicaid unwinding for Kansas (3/31/24):

298,529 enrollees renewed coverage

66,311 determined ineligible


**13,342** in reinstatement window

# **COVID-19 impacted MCH program capacity**

The number of counties served dropped from 76 in 2020 to 62 in 2023



The number of counties receiving


MCH Universal Home Visiting dropped

from 64 in 2020 to 52 in 2023



# Challenges to MCH workforce

The MCH workforce is aging and predominantly white compared to the populations they serve which can lead to **cultural and language/communication challenges** which are often **cited as barriers to quality care**.



25%

of surveyed Kansas MCH professionals indicated they are likely to change positions soon despite most expressing high job satisfaction


- ✓ Census data

- ✓ MCH program focus groups (virtual)
- ✓ PhotoVoice (adolescents and the Family Advisory Council)

#### **Emphasizing:**

- Perspectives of providers (primarily interviews and surveys) and individuals with lived experience (interviews and focus groups)
- Integration with other statewide assessments

# COMMUNITY BASED CHILD ABUSE AND NEGLECT PREVENTION (CBCAP)

CBCAP funds support primary and secondary prevention efforts. Primary prevention includes efforts targeted to the broader community to strengthen families and prevent the likelihood of abuse or neglect. Secondary prevention efforts are targeted to special populations, as a means of providing preventative family strengthening support.
