This grant opportunity was made possible by funding allocations from four sources:

- \$20 million in Strengthening People and Revitalizing Kansas (SPARK) funds allocated by the state legislature (American Rescue Plan Act (ARPA) State Fiscal Recovery Fund)
- \$31 million in Child Care Development Fund (CCDF) ARPA Discretionary Fund made available by Department for Children and Families (DCF)

- \$1 million in Preschool Development Grant (PDG) Planning grant funds awarded to Kansas Children’s Cabinet and Trust Fund (KCCTF)
- \$2.5 million in collaboration support from the Patterson Family Foundation

As stated in the RFP, the Child Care Capacity Accelerator (CCCA) grants are intended to *“support communities in creating sustainable, high-quality child care. Funding is intended for communities positioned to make transformational investments in child care and early learning solutions that will impact generations to come. In doing so, it will support economic growth, meet the needs of local businesses, create new jobs with better compensation (living wages) for early educators, and support workforce participation by families with young children.”*

The Child Care Innovation Communities piloted innovative strategies to expand child care capacity in six categories: Infant/Toddler Incentives, Child Care Plus Models, Workforce Recruitment and Retention, Non-Traditional Service Hours or Targeted Populations, Rural Child care, and Public/Private Funding Partnership. Grantees participated in a 12-month cohort program from July 2023–June 2024 that involved co-creation and peer learning sessions, regular data reporting and evaluation efforts, and monthly coaching sessions.

The north star throughout the process – both in advising applicants and in reviewing applications – was the use of these dollars to create more sustainable, licensed child care seats across the state and accelerate the capacity-building and innovative efforts of Kansas communities.

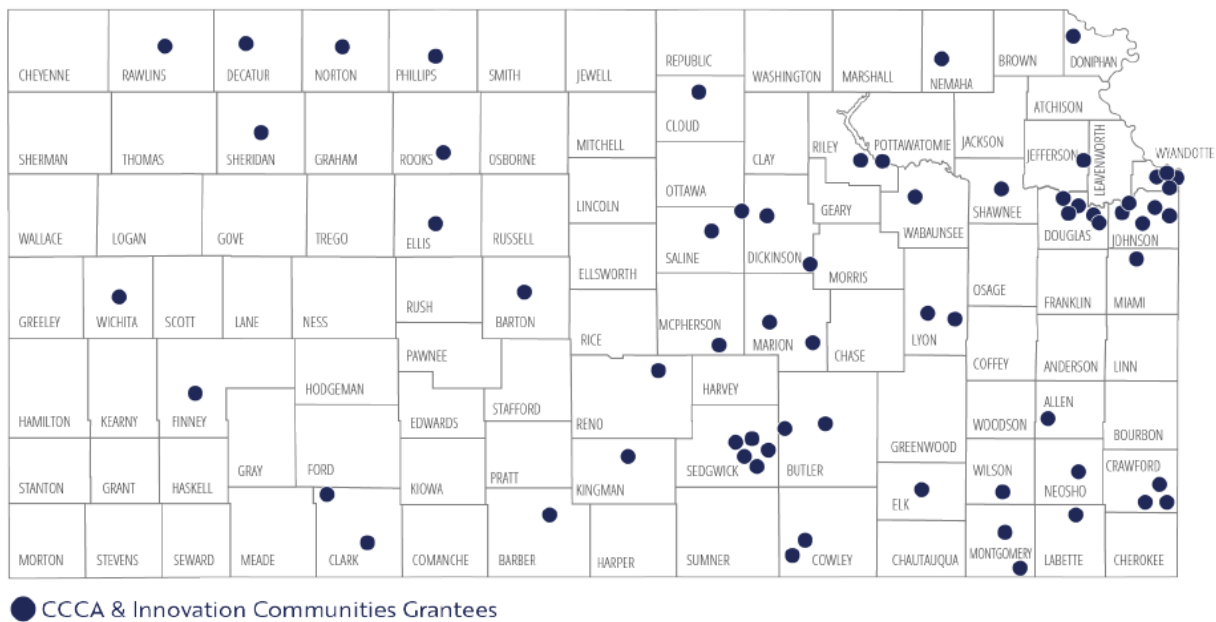
The KCCTF team worked closely with DCF, KDHE, KSDE, Kansas Commerce, and the team at Child Care Aware of Kansas, to ensure other available construction funding across the state was being leveraged and award recommendations aligned with allowable expense guidelines for each of the funding sources involved in the RFP. Project viability, geographic diversity and an emphasis on community-driven solutions to the child care crisis were factored in to the review process.

Discovery Child Care Learning Center has started an additional project and operational support will help purchase required equipment and supplies for when the project is complete. Project will also increase wages for all existing teachers through a bonus retention program. An important innovation of this project team is their regional sub-pool, "Customized Early Education". Reno County Child Care Taskforce

Accelerator Overview

Under the leadership of the Chamber of Commerce, The Reno County Child Care Task Force has worked since 2017 to develop a collaborative, countywide project involving six partnering organizations and eight distinct projects to address child care capacity challenges in Reno County. Four of these projects are located in communities with less than 1,500 people, where licensed, quality child care providers are most scarce. The initiative includes five renovations and three new facilities, with the majority being existing providers offering expanded services and would serve over 300 children. (Application # 3852)
