# Well-Being & Prevention Efforts

#### OVERVIEW

- Connecting children to early childhood services promotes overall well-being and prevents ACEs.
- Upstream, primary prevention services are tools that empower parents and caregivers to take charge of their family's well-being.
- National shifts toward prevention and well-being:

Family First Prevention and Services Act of 2018

o Thriving Families, Safer Children (2020)



#### **COST EFFECTIVENESS**

- Reduces long-term costs by keeping children out of foster care.
- Investing early reduces the likelihood of the cycle of child welfare repeating.
- Investing in proactive, community-based services versus more costly services, like foster care, is fiscally responsible.



Alia Innovations social return on investment (SROI) study (2019):

- Analyzed SROI based on annual per child cost of foster care placement using best- and worst-case scenario experiences.
- oBest-case scenario: For every \$1 spent = \$-3.64 ROI
- •Worst-case scenario: For every \$1spent = \$-9.55 ROI



### COST AVOIDANCE

State of Kentucky example

• Data from SFY19-21 indicates prevention funding increased by \$9.8M and out-of-home expenditures decreased by \$58.1M (900 less children in foster care and reductions in congregate care).

 Kentucky SFY2022 budget included \$1000 in flexible funding for families participating in family preservation to meet concrete needs and prevent removal into foster care.



Family Resource Centers Return on Investment

- Alabama: For every \$1 invested = \$4.93 savings to the state in immediate and long-term financial benefits.
- Orange County, CA: Overall ROI to the child welfare system = \$3.65.

 Teller County, CO: Overall ROI to the child welfare system = \$2.92 and a 63% reduction in its child maltreatment rate.



#### **KANSAS PREVENTION CONTINUUM**

Investment in upstream approaches

 Family First Prevention Services early adopter (2019) resulting in \$13M of federal funding for community-based services for families.

•Thriving Families, Safer Children cohort member (2021)

#### Getting Started —

The county is in the early stages of addressing the needs of children and families with significant gaps in resources and support, a need for greater infrastructure, and community collaborations. Strengthening The county is making good progress but still has room for improvement with a solid foundation. Some areas may require further development to ensure consistent access to services and improved well-being outcomes.

The county is meeting the needs of children and families. The county demonstrates strong outcomes in key well-being indicators, with minimal gaps or barriers.



Financial well-being involves the ability to meet current and ongoing financial obligations, such as basic needs like food, housing, utilities, health care, transportation, education, child care,... Learning and development encompass the processes and experiences through which individuals acquire knowledge, skills, and competencies over time. This includes access to education, attainme...

Family and household well-being encompasses the overall functioning and quality of life of a family unit or group of individuals living in a shared dwelling. It involves positive interactio...

#### KAN-LINK

Kansas Linking Infrastructure for Nurturing Kids (KAN-LINK)

- o3-year child welfare discretionary grant (in year 2)
- •Systems-level support to increase access to quality early childhood services as a protective factor to prevent child welfare involvement.
- •Statewide and local approaches partnering with Family Resource Centers.



#### CBCAP

Community-Based Child Abuse Prevention (CBCAP)

- Annual federal formula funding (CAPTA) intended to prevent the likelihood of child abuse and neglect.
- Aid to local funding for primary and secondary prevention. Nine community-based grantees.
- Statewide initiatives: Child Abuse Prevention Month, Governor's Conference on the Prevention of Child Abuse and Neglect



#### EARLY CHILDHOOD

- Guided by the All In For Kansas Kids Early Childhood Strategic Plan
- Early Childhood Block Grant
- Preschool Development Grant
- Dolly Parton Imagination Library





Investments in prevention and well-being in Kansas have:

- Increased access to supportive family services.
- Reduced need for foster care.
- Contributed to improvements in family well-being (e.g., child social-emotional development, safety, mental health parenting, substance use, educational achievement).



#### **RETURN ON INVESTMENT**

- Kansas ECIDS pilot study: CIF and CBCAP contribute to the well-being of families.
- Participating in early childhood services significantly reduced the likelihood of removals into foster care by 28%.
- Preventing removals makes fiscal sense, reduces harm, and keeps families together. For every dollar invested in ECBG/CBCAP, Kansans reap an 11% return on investments by reducing economic burden in other systems.



#### CHILD WELFARE IMPACT

- Steady decrease in child welfare in out-of-home placements.
   Since SFY19 Dec SFY25 = 23% reduction of children in foster care.
- Family First Prevention Services:
  - o Over 6,000 children referred for services Oct 2019-2024.
  - 90% of target children and youth who have reached 12 months from time of referral have remained together at home without the need for foster care.
- Southeast Kansas impact: 29% decrease in OOH placement from SFY21 to Dec SFY25.



#### EARLY CHILDHOOD & K-12 IMPACT

- The Opportunity Project (TOP) partnership with Wichita USD 259
- Ongoing longitudinal study 2008 present
- TOP graduates consistently have better test scores, higher GPAs, fewer SPED placements, fewer discipline referrals, and lower suspension rates than the control.
- Cost analysis = 11% annual return on investment to the state



### LOOKING AHEAD

Aligned with Health Rise call to action, The Children's Cabinet is contributing to improving the health of all Kansans.

- Leveraging Kansas Thriving Families
- Replicate innovations expanding cross-system linkages in new sectors (e.g., EC, IPV, MH, and SUDS)
- Expand coordinated intake and integrated service coordination (e.g., hub models, FRCs, community network)
